For rental properties, owners may choose a secondary delivery method provided one is sent by mail and the other by email.</p> <p>A connection fee of \$40.00 will be added to the first bill.</p> <p>Failure of the owner to receive a billing shall in no way affect the liability to pay the account.</p> <p>In the event a utility bill remains unpaid after 20 days following the utility bill mailing date a penalty of 2.5% will be added and form part of the utility bill. If utility charges remain unpaid after the penalty date the municipality may take recovery action as outlined in Bylaw 14/2024.</p> <p>RESIDENTIAL ONLY:</p> <p>Once a utility account is created, residents may request a landfill card to have the option of taking extra garbage and yard waste to the regional landfill operated by Roseridge.</p> <p>Waste carts are specifically allocated to each individual property and are not transferable between properties at anytime. Cart(s) will always remain the property of the Town of Morinville.</p>
